LIGHTPEN

Your new Vectrex Light Pen is an add-on component to the Vectrex Graphic Computer System that allows you to interact directly with the built-in Vectrex screen. With the Light Pen and special Vectrex Light Pen cartridges, you'll be able to draw, compose music, play educational games and even create your own animation.

Your Vectrex Light Pen will work only with specially developed Light Pen cartridges that plug into the same slot as your Vectrex game cartridges.

The Vectrex Light Pen plugs into the *left outlet* on the front of your Vectrex — the same outlet used for a second control panel. You'll never actually see any light coming from the pen, but it will be working as soon as it is plugged in, a special Light Pen cartridge is inserted in the cartridge slot and your Vectrex console is turned on.

IMPORTANT:

Adjust the brightness control (on back of console) so the white dot in the center of the screen just barely disappears. If the brightness control is set too dim, the Light Pen will not provide maximum performance.

90 Day Limited Warranty

This Vectrex™ Graphic Computer System Light Pen is warranted by General Consumer Electronics, Inc. to the original consumer purchaser in the U.S.A. for a period of 90 days from the original purchase date under normal use and service against the defective workmanship and materials. **Any implied warranties are also limited in duration to the 90 day period from the original purchase date.
